- Pre-bid meeting shall be held at **Sainamaina Municipality** Office at 1:00 pm on 2075-09-16.
- Sealed bids must be submitted to the office **Sainamaina Municipality** by hand on or before 12:00 noon on 2075-09-23. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2075-09-23 at the office of **Sainamaina Municipality**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting to a minimum of Rs. 67,000(Sixty Seven Thousand only), which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- The Office of Sainamaina Municipality, Buddhanagar, Rupandehi reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to award contract.
