1. *Sainamaina Municipality* has received a grant from *GoN* towards the cost of *Construction of 150mm dia Deep Boring Works* and intends to apply part of the funds to cover eligible payments under the Contract for *NCB/04/075-76*.
2. *Sainamaina Municipality* invites sealed bids from registered drilling company with key qualification of minimum work experience of 2 (Two) at least 100m deep boring works, for the *Construction of 150mm dia Deep Boring Works* under National Competitive Bidding procedures.

A complete set of Bidding Documents may be purchased from the office *Sainamaina Municipality, Buddhanagar, Rupandehi* by registered drilling company on the submission of a written application, along with the copy of company/firm registration certificate, business registration certificate, tax clearance up to 074/75, VAT registration certificate, Municipal business registration certificate (only if the head/branch office is located at *Sainamaina Municipality*) and upon payment of a non-refundable fee of *Rs.3000* till 2075-10-20.

5. Pre-bid meeting shall be held at *Sainamaina Municipality Office* at 1:00 pm on 2075-10-11.
6. Sealed bids must be submitted to the office *Sainamaina Municipality* by hand on or before 12:00 noon on 2075-10-21. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2075-10-21 at the office of *Sainamaina Municipality*. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting to a minimum of *Rs. 67,000(Sixty Seven Thousand only)*, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The Office of *Sainamaina Municipality, Buddhanagar, Rupandehi* reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to award contract.
