## Invitation for Bids for the Construction of Administrative Building and Other Infrastructures of Sainamaina Municipality

The Government of Nepal [GoN] has allocated funds towards the cost of Construction of Administrative Building and
Other Infrastructures of Sainamaina Municipality and intends to apply part of the funds to cover eligible payments under
the Contract for Construction of Administrative Building and Other Infrastructures of Sainamaina Municipality (Contract
No: NCB/02/075-76). Bidding is open to all eligible bidders as per Section V of Bidding Document

 Sainamaina Municipality, Rupandehi invites electronic bids from eligible bidders for the Construction of Administrative Building with Lift system, Guard House, Lab, Public Toilet, Canteen and Main Gate, under National Competitive Bidding-Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 30,000,000 (Without VAT)
- Minimum Work experience of similar size and nature: Participation as Prime contractor, management contractor, or subcontractor, in at least one (1) contracts of Building Construction of Value NRs. 24,000,000 (Without VAT)
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

4. Eligible Bidders may obtain further information at the office of Sainamaina Municipality, Rupandehi, Buddhanagar, Rupandehi, Sainamaina, Rupandehi, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.

Bidder must submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www. bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document of non-refundable fee of NRs. 5000 in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

- Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 24th December, 2018. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 24th December, 2018 at the office of Sainamaina Municipality, Rupandehi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of NRs. 800000 which shall be valid for 30 days beyond the validity period of the bid.
- 9 If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. If any Provisions of Bid documents are inconsistent with Public Procurement Act (PPA), 2063 and Public Procurement Regulations (PPR), 2064, the provisions of Bid document shall be void to the extent of such inconsistency and the provisions of PPA and PPR prevail.
