6. Electronic bids must be submitted to the office **Sainamaina Municipality** through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 noon on 2076-11-13**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 pm on 2076-11-13** at the office of Sainamaina Municipality. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to a minimum of **as mentioned below shall be deposited in the bank A/C no. 0414201149244015 of Agricultural Development Bank Ltd, Parroha Sakha** which shall be valid for 30 days beyond the validity period of the bid.
